



## **Be patient**

- Most RVS Vice Chairs will review it within 1-2 weeks.
- Allow up to 4 months.

- Contact the MOC CHAIR if you do not receive a response from your Vice Chair within a week.







#### Duplicates slow approval! FIRST, Check the status in "My Applications"!
